3. Terms and conditions for free transfer services:

5. Amendments fees for date changes or name changes apply to all received bookings.
6. All participants must stay with the tour group as per the itinerary from beginning to end. A penalty of \$99 per person per day will apply in the event of any deviation from the tour itinerary. Nexus Holidays shall not be responsible for any act thereafter.
7. Only passengers listed on the same booking are guaranteed to travel together on the same tour and coach. If you are travelling with a group, please ensure all names are listed on the same reservation form otherwise there is a risk that you will be allocated to different coaches.
8. Cancellation by Customer
 

All cancellations must be made in writing to your travel agent and will be subject to the following cancellation and refund policies from the date the written cancellation is received:

  - a. Tours under \$200: tour fee is non-refundable.
  - b. Land-only tours above \$200:
    - More than 30 days prior to departure, \$50 per person cancellation charges will be applied;
    - Between 8-29 days prior to departure, \$200 per person cancellation charges will be applied;
    - 7 days or less prior to departure, 100% tour fee is non-refundable.
  - c. Air and land tours:
    - Air tickets have not been issued, \$200 per person cancellation charges will be applied;
    - Air tickets have been issued and more than 15 days prior to departure, \$1000 per person cancellation charges will be applied;
    - 15 days or less prior to departure, 100% tour fee is non-refundable.
